

CELEBRATE AG CONTEST RULES AND REGULATIONS

- 1. The "Celebrate Ag Contest" (the "Contest") is produced by BC Agriculture in the Classroom Foundation (BCAITC).
- 2. The Contest starts at 1:00pm PST on Monday, December 7, 2020 and closes 12:59pm PST on Thursday, December 17, 2020.
- 3. To enter and to be eligible to win the Contest, entrants must be a legal resident of British Columbia, a teacher or home educator, and 18 years of age or older. Employees and their parents, siblings, children, and persons domiciled with an employee of BCAITC and any other organizations who assist or aid in the Contest are ineligible to enter.
- 4. No purchase necessary. To enter, entrants must comment as to "how they have connected their K-12 BC students to agriculture in 2020" in the comments section below the December 7, 2020 Contest post online at www.twitter.com/bcaitc, www.facebook.com/bcagintheclassroom, and/or www.instagram.com/bcaitc. Odds of being selected as a winner depend on the number of entries received by the Contest. All entries must be received by 12:59pm PST on Thursday, December 17, 2020.
- 5. By entering, Contest entrants acknowledge that the Contest is in not sponsored, administered, or associated with Save-On-Foods, Twitter, Facebook, or Instagram. Contest entrants agree that he/she owns rights to the entrant-generated content entered in the Contest and that entrant-generated content does not infringe on copyrights or other legal rights. Entrants give BCAITC permission to reproduce and use this entrant-generated content in connection with the Contest. BCAITC may refuse to accept entrant-generated content for any reason.
- 6. There are four (4) contest Grand Prizes, each consisting of a Save-On-Foods gift card valued at twenty-five dollars (\$25). Prizes must be accepted as awarded. No substitutions of the prizes are permitted, except at BCAITC's sole discretion. BCAITC is not responsible for lost or stolen prizes.
- 7. A random Contest prize draw will be conducted between 1:00pm and 4:00pm PST on Thursday, December 17, 2020 at BCAITC's office in Abbotsford, BC from the entries received. Winners will be contacted via Twitter, Facebook, and/or Instagram immediately following the daily draws. Winners must reply within a seven (7) day period. In the event that attempts to contact winners are unsuccessful, alternative entries will be selected at random.
- 8. Before being awarded a prize, a potential Contest winner will be required to sign and return within seven (7) days, a completed Contest release form stating, among other things, that a potential Contest winner has agrees to the Contest Rules and Regulations, grants all consents required, authorizes BCAITC to broadcast and publish the winners' name, city of residence, and entrant-generated comments in connection with promotion or publicity of the Contest at no additional compensation to a potential winner, and without mechanical aid, completes a mathematical skill-testing question, before a selected entrant is confirmed as a winner. If, for any reason, a potential Contest winner fails to return a completed Contest Release within seven (7) days, he/she will forfeit the prize and BCAITC reserves the right, but not the obligation, to draw another entry. A Contest winner will be delivered a prize by mail within twenty-one (21) days of the Contest draw.
