# EXECUTIVE DIRECTOR'S REPORT

---

I am beyond thrilled to have joined BCAITC as its new Executive Director in August 2025. Having grown up in a multi-generational farming family, I have deep roots in BC's agricultural community. Since joining BCAITC, I have been utilizing my extensive non-profit leadership experience to build strong partnerships, and guide strategic growth in support of ensuring students across the province gain transformative connections to BC food and the people, places and process behind it.

Upon reflection on my first few months with BCAITC, 2025 was a year of growth, new ideas, and meaningful connections for us! Across the province, we continued supporting educators and helping students better understand where their food comes from through hands-on learning, classroom resources, and agriculture experiences that bring BC's food and farming story to life.

A key milestone this year was the rebranding of our BC School Fruit and Vegetable Nutritional Program + Milk to FRESH for KIDS. While the name has changed, our commitment remains the same, delivering fresh, local BC fruits, vegetables, dairy, and eggs to schools across the province. We also introduced expanded delivery week options, giving schools greater flexibility to tailor the program to their needs. We are grateful to our many long-standing program partners and supporters for their continued dedication to connecting K-12 students to local food and agriculture throughout BC.

In partnership with AITC Canada, students took part in Canadian Agriculture Literacy Month (CALM) through the Blooming Wellness: A Reading Contest Celebrating Plants and Growth, sparking curiosity through stories and classroom activities. Together, we also hosted the Great Canadian Farm Tour, featuring a virtual visit to Farmers Fresh Mushrooms in BC, offering students a closer look at mushroom production.

Classroom-based hands-on learning through our programs continues to grow. Spuds in Tubs saw a 4.75% increase in registrations, while Common Ground: The Strawberry Project reached 51 communities

across the province, strengthening connections to local food systems. Ag Adventures at Helen's Acres, Kelowna and The Pencil Patch, Abbotsford, continued to offer memorable, place-based learning experiences for students and homeschooling families. We also developed and launched new resources focused on garlic, grains, pumpkins, and eggs. These lesson plans brought BC agriculture into everyday learning in practical and engaging ways, helping students build stronger connections to food and farming.

This year, we were especially proud to launch our new Gardening Camps at The Pencil Patch, a hands-on, educational summer day camp series for children ages 6–11, offering a fun and safe environment to explore plants, nature, sustainability, and gardening basics.

Students explored agriculture careers through thinkAG field trips across Vancouver Island, the Fraser Valley, and the Okanagan, made possible through the support of our federal and provincial partners. In November, our Fresh for Less fundraiser brought communities together through affordable bundles of fresh BC produce, raising almost \$12,000 for agricultural education.

We are deeply grateful to our industry partners, donors, educators, and volunteers who bring agriculture to life in classrooms across BC. As we look ahead, we do so with deep appreciation for everyone who makes these programs possible, and with continued inspiration from the curiosity of students and the dedication of teachers across the province.

# PROGRAMS



Formerly the BC School Fruit and Vegetable Nutritional Program + Milk (BCSFVNP+Milk), BCAITC's flagship program has been rebranded as **FRESH for KIDS**, reflecting its focus on providing fresh, nutritious BC foods while strengthening connections to local agriculture.

With the support of nearly 2,400 dedicated volunteers and valued industry partners, FRESH for KIDS brings BC-grown fruit, vegetables, dairy, and protein snacks directly into classrooms across the province. The program helps students access fresh, locally sourced foods while learning about healthy eating, agriculture, and the journey from farm to table.

During the 2024–25 school year, participating schools received deliveries for up to 24 weeks between September and May, with flexible 12 or 24-week enrolment options. Funding to school districts through the Province's Feeding Futures initiative helped expand participation, ensuring more students benefited from nutritious snacks during the school year. The program serves public, independent, and First Nations schools across British Columbia, supported by Pattison Food Group, Saputo, BC Agriculture Commodity Groups and a network of independent and volunteer drivers.

Teachers also receive Fresh Story and Grow BC resources that connect classroom experiences to curriculum outcomes and help students explore BC agriculture and healthy food choices. This year included the addition of individually wrapped cooked eggs as a new protein option, along with updated logistics and communication systems to support program growth. Through strong collaboration, FRESH for KIDS continues to strengthen farm-to-school connections and student nutrition across BC.

BC students deserve to cook and eat only the best — and that's fresh, healthy BC grown products! Each year, BC Agriculture in the Classroom Foundation, partners with the BC Culinary Arts Association, BC agricultural commodity groups, and BC producers to deliver fresh, BC grown product five times a year to BC secondary schools with a Culinary Arts program. Through the **Take a Bite of BC** program teaching chefs provide information about the contributed foods from BC farmers and producers, and the students are inspired to create recipes featuring these products to offer the student population at their school.

## NEW Gardening Camps for Kids

Our new **Gardening Camps** at The Pencil Patch in Abbotsford offer children ages 6–11 a fun, hands-on introduction to gardening and the natural world. Through outdoor, garden-based activities, students explore how plants grow, where food comes from, and the basics of soil, seeds, and sustainability. Children learn by doing—digging, planting, and discovering in a safe, engaging outdoor space. Most of all, they enjoy time outside while connecting to food, farming, and nature in British Columbia.

Through the **Harvest Bin Project** we provide schools in 15 communities across BC with recycled harvest bins as raised garden beds as together with seed funds and mentorship for establishing their own growing gardens. Growing their own food connects students directly to agriculture and the larger world, giving them a deeper understanding of food security and sustainable food systems. Students are involved in the growing process from setting up the bins, to planting, growing, and harvesting a wide variety of crops. The Harvest Bin Project helps support the learning objectives for a variety of classrooms, from caring for the soil to learning about plant life cycles and pollinators, this program models the principles of sustainable agriculture.

## Summer Institute

Every July, teachers hungry to expand their knowledge of agriculture become the students at BC Agriculture in the Classroom and the UBC Faculty of Education's **Summer Institute** course in Abbotsford, led by instructor Joe Massie. Through active participation on field trips with local Farmer Bill Zylmans, and various guest speakers, participants in this five-day course explore practical ways to integrate concepts related to food production and consumption, food safety, agricultural issues, and sustainability across the curriculum at all grade levels. The meals for the week and hands on food preparation sessions are prepared by BCAITC's Chef Ambassador and Maple Ridge Secondary Culinary Instructor Trevor Randle. The result is customized curriculum projects and lesson units developed by the participants that can be shared with students, as well as other educators and agriculture enthusiasts around the province, and are rich in agricultural literacy.

# 2025 OUTSTANDING TEACHER IN AGRICULTURE

BC Agriculture in the Classroom Foundation (BCAITC) is pleased to announce **Cailyn Morash** as the recipient of the 2025 BCAITC Outstanding Teacher in Agriculture Award. The award was presented to Cailyn at the BC Agriculture Council's Policy Forum Gala in Penticton for demonstrating outstanding leadership and innovation in agriculture education.

Cailyn Morash is a Grade 6 Math/Science teacher from Glenrosa Middle School in West Kelowna, where her passion for agriculture and food education stems from the intention of sharing the unique richness of BC's local farms and food systems with her students. Since joining the teaching profession four years ago, Cailyn has made it a priority to educate students about BC's agriculture and food, fostering a deeper understanding of where our food comes from and its connection to sustainable practices.

Cailyn remarks "As a teacher, I want my students to develop a deep understanding of where their food comes from, including the journey it takes from farm to table. I also want them to cultivate a meaningful relationship with the land, recognizing its importance, respecting its resources, and appreciating the role it plays in supporting our communities and food systems."

Cailyn credits BCAITC programs like Spuds in Tubs for inspiring her students. She shares "Watching my students' excitement as they return from spring break to see how much their potato

plants have grown is truly heartwarming. It's such a hands-on and engaging way to teach students about plant growth, food production, and the joy of cultivating something themselves. The program sparks curiosity and brings learning to life in a memorable and meaningful way!"

For educators seeking to integrate agriculture and food education into their classrooms, Cailyn advises: "Look for opportunities where agriculture and food education can fit naturally within your existing curriculum. It doesn't have to be a large-scale project—it can be as simple as incorporating discussions about where food comes from during science, math, or even art lessons. Small, meaningful connections can make a big impact and engage students in a hands-on, real-world learning experience. The key is to bring in these concepts organically and make them relevant to your students' daily lives!"

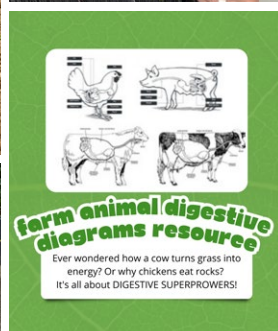
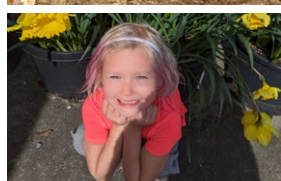

# EDUCATION SPECIALIST'S REPORT

---

2025 was a dynamic and rewarding year for BCAITC's education programs, filled with new resource development, meaningful partnerships, and continued engagement with educators and students across British Columbia. Through a combination of classroom learning, hands-on experiences, and professional development opportunities, we continued to support food literacy in BC classrooms and strengthen connections to where food comes from.

This year, we expanded classroom resources that bring agriculture into everyday learning. New lesson plans on garlic, grains, and pumpkins were introduced, along with ongoing work on the Intermediate and Secondary Egg Kits. In partnership with the Ministry of Agriculture and Food, we launched the BC Food Classroom Challenges, giving students interactive ways to explore key agricultural commodities. Programs like Blooming Wellness and Canadian Agriculture Literacy Month (CALM) also encouraged students to learn about plants, food systems, and agriculture through reading and classroom activities.

Supporting educators remained at the heart of our work. We delivered workshops and presentations at conferences and professional development events across the province, including Tapestry, COTA, myPITA, THESA, and the Career Education Society Conference. These sessions gave teachers practical tools they could use right away in their classrooms. Our Teacher Ambassador program also continued to grow, strengthening peer-to-peer support and expanding our reach within the education community.

We also continued to connect with future educators through post-secondary teacher training programs. This included a presentation to the Home Economics teacher candidate cohort at UBC in November 2025, helping introduce agriculture and food literacy resources to new teachers early in their careers.

Hands-on learning remained a key part of our programming. thinkAG career field trips reached students across Vancouver Island, the Fraser Valley, and the Okanagan, offering real-world insight into careers in agriculture. Ag Adventures at Helen's Acres also continued to provide memorable, place-based learning experiences, supported by dedicated staff and volunteers. These opportunities helped students connect directly with farmers, food producers, and industry professionals.

2025 also brought continued collaboration and transition. Partnerships, including ongoing work with the Ministry of Agriculture and Food, helped expand our programs and resources. The onboarding of a new Executive Director marked an important step forward for the organization, supported by a committed and experienced team. Through newsletters and outreach, we continued sharing classroom stories, resources, and teacher experiences across the province.

As we look ahead, we are excited to build on this momentum. With our 2026 theme, Cultivating Curiosity, we remain committed to supporting educators, inspiring students, and strengthening food literacy in BC classrooms through meaningful, hands-on learning. Thank you to everyone who has contributed to bringing our programs and resources to life—you are making significant strides in the sharing of BC's Food and Farming Story!

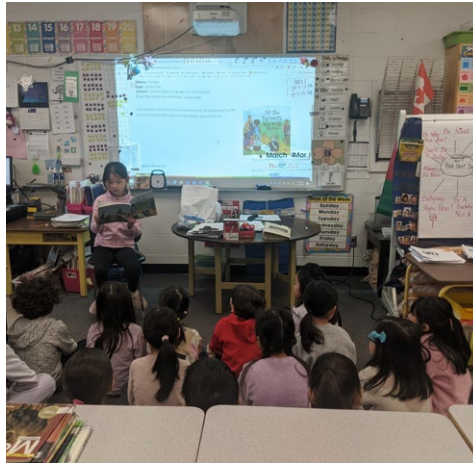

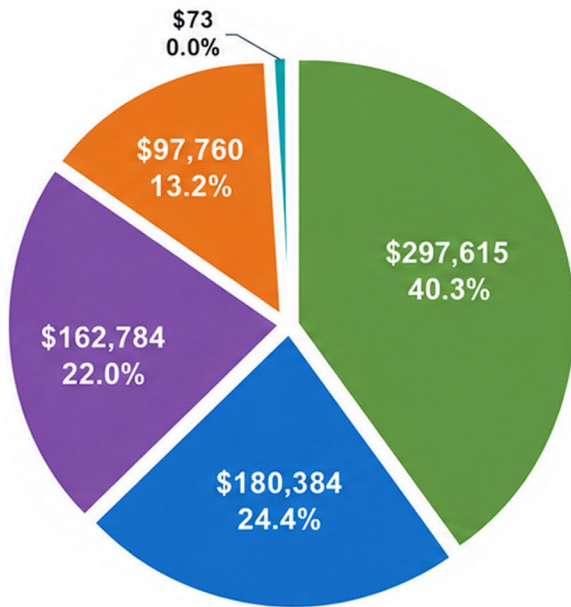

## 2025 REVENUE SOURCES

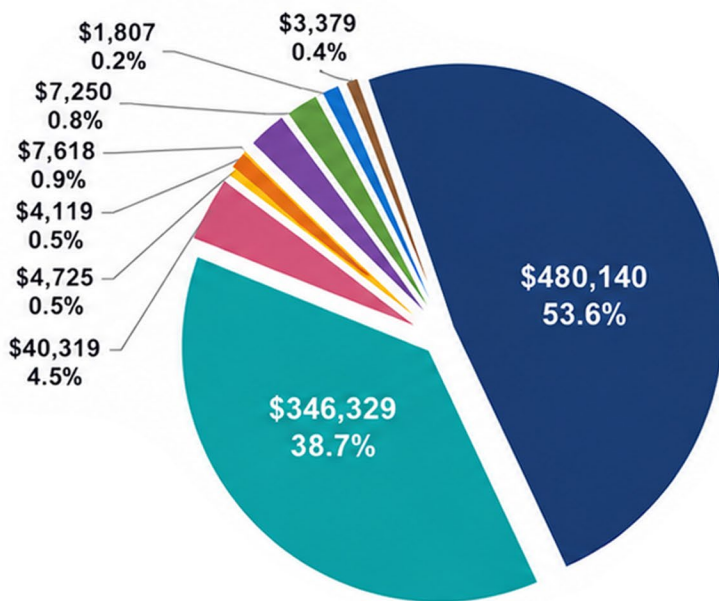

## **Basis for Qualified Conclusion**

In common with many not-for-profit organizations, British Columbia Agriculture in the Classroom Foundation derives revenue from fundraising activities, the completeness of which is not susceptible to me obtaining evidence I considered necessary for the purpose of the review. Accordingly, the evidence obtained of these revenues was limited to the amounts recorded in the records of British Columbia Agriculture in the Classroom Foundation. Therefore, I was unable to determine whether any adjustments might have been found necessary with respect to fundraising revenue, excess of revenue over expenses, and cash flows from operations for the years ended December 31, 2025 and 2024, current assets as at December 31, 2025 and 2024 and net assets as at January 1 and December 31 for both the 2025 and 2024 year ends. My conclusion on the financial statements for the year ended December 31, 2025 was modified accordingly because of the possible effects of this limitation in scope.

## **Qualified Conclusion**

Based on my review, except for the possible effects of the matter described in the Basis for Qualified Conclusion, nothing has come to my attention that causes me to believe that the financial statements do not present fairly, in all material respects, the financial position of British Columbia Agriculture in the Classroom Foundation as at December 31, 2025, and results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

**1. PURPOSES OF THE ORGANIZATION**

British Columbia Agriculture in the Classroom Foundation is a non-profit organization and was incorporated under the *Society Act* of British Columbia on August 9, 1999. The foundation is a charity registered under section 149(1)(i) of the *Income Tax Act* and is therefore not subject to taxation.

The purposes of the foundation are:

- to promote an awareness and understanding of sustainable agriculture and food systems in B.C. Schools;
- to enable students to make informed decisions about food choices, food safety, the importance of our own supply of food and other agriculture products as well as the protection of B.C.'s agriculture resources;
- to foster awareness of careers to be found in agriculture and food systems;
- to attract funding for the research, development and implementation of programs to meet the above stated purposes of the society;
- to provide classroom ready resource material and activities on the agri-food system which can be integrated into the existing school curriculum;
- to provide in-service professional development on the agri-food system for British Columbia teachers; and
- to establish a clearing house of agri-food system resources for classroom teachers.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accounting policies of the foundation are in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO). Outlined below are those policies considered particularly significant.

The financial statements have, in management's opinion, been properly prepared within reasonable limits of materiality and within the framework of the accounting policies summarized below:

**(a) FUND ACCOUNTING**

The Foundation follows the restricted fund method of accounting for contributions.

The General Fund accounts for the organization's program delivery and administrative activities. This program reports unrestricted resources and restricted operating grants.

The Capital Asset Fund reports the assets, liabilities, revenues and expenses related to the Foundation's Capital Assets.

**(b) INVENTORY**

Inventory, which is comprised of publication materials held for distribution, is valued at the lower of cost or replacement cost.

**(c) USE OF ESTIMATES**

When preparing financial statements in accordance with ASNPO, the Foundation makes estimates and assumptions relating to:

- Reported amounts of revenues and expenses;
- Reported amounts of assets and liabilities; and
- Disclosure of contingent assets and liabilities.

Management's assumptions are based on a number of factors, including historical experience, current events and actions that the organization may undertake in the future, and other assumptions that I believe are reasonable under the circumstances. Actual results could differ from those estimates under different conditions and assumptions. Estimates were used when accounting for certain items, such as the useful lives of assets, impairment of long-lived assets and deferred operating grants.

Amortization is based on the estimated useful lives of property, plant and equipment. These estimates and assumptions are reviewed periodically and, as adjustments become necessary they are reported in the periods in which they became known.

**(d) REVENUE RECOGNITION**

Restricted contributions are recognized as revenue in the year when related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Unrestricted investment income is recognized as revenue when earned.

The Foundation uses risk management to monitor and manage its risk arising from financial instruments. These risks include credit risk, interest rate risk and market risk.

The Foundation does not use any derivative financial instruments to mitigate these risks.

**Credit risk**

Credit risks arise from two sources; cash and cash equivalents and accounts receivable. Cash and cash equivalents are deposited with reputable, major financial institutions to limit the credit risk exposure. The credit risk from parties not paying accounts receivable is not considered to be significant.

**Interest rate risk**

The Foundation is exposed to interest rate risk with respect to cash equivalents. Changes in interest rates can affect the fair value of investments and the cash flows related to interest income and expense.

**Liquidity risk**

Liquidity risk exposure is dependent on the receipt of funds from Provincial Government grants and other sources to enable the Foundation to pay its liabilities as they become due.

**Market risk**

In the Directors' opinion, the Foundation is not exposed to any significant market risk.

**(g) CAPITAL ASSETS**

Capital Assets are recorded at cost. Amortization has been calculated using the following methods and rates as follows, except in the year of acquisition when one half of the rate is used. No amortization is applied in the year of disposal.
